To be considered for funding, the following documents must be included to avoid disqualification:

MUST COMPLETE APPLICATION AND REQUIRED DOCUMENTS ELECTRONICALLY:

- 501c(3) IRS Tax Determination Letter – status will be verified with State of California Attorney Generals' Office.
- Current List of Board of Directors with Name, Address and contact information.
- Brochure: Organization may include **ONLY ONE** printed brochure or informational piece.

Application is due on May 8th, 2019, BY 3:00 P.M.

### Application Guidelines & Policies

Our policies and guidelines for funding are as follows:

1. Application must be completed and submitted electronically.
2. Application must be completed in its entirety.
3. Application must be for a program exclusive to your community (i.e. Stockton, Lodi, Manteca/Lathrop/Escalon/Ripon).
4. An Agency representative may be required to attend an interview if the Community Council has any questions about the application.
5. Funded agencies will be required to submit a FINAL REPORT which outlines the success and progress in order to be eligible for future funding. Possible mid-year check-ins will be conducted.
