

Alliance for Wellness

The Alliance for Wellness is a community care hub that aims to improve health outcomes by coordinating care and addressing social determinants of health through community health workers (CHWs). Qualified community-based nonprofit organizations contract with the hub to deliver community-based care coordination services that align with California's CalAIM initiative and utilize the evidence-based Pathways Community HUB Institute® (PCHI®) Model.

Purpose

The AFW aims to improve health outcomes by coordinating care and addressing social determinants of health through community health workers (CHWs). **Target populations include Justice-Involved, Birth Equity, High Utilizers of Emergency and Hospital Care.** Selected CCAs will employ CHWs trained to navigate and close Pathways addressing health-related social needs (HRSN), most notably:

- Access to care and benefits navigation
- Employment and transportation support
- Housing through navigation, tenancy, and sustaining services support
- Medication screening, reconciliation, and adherence
- Asthma remediation through qualified supplies and physical modifications
- Food access and security, especially Medically Tailored Meals for those with chronic conditions

Eligibility

Community-based nonprofits with experience employing CHWs or willingness to hire CHWs with a proven track record working with identified populations in San Joaquin and Stanislaus Counties. The nonprofits should demonstrate readiness to provide CHW care coordination through existing service delivery and community-based programming experience.

Selected CCAs must have the intent to subcontract with AFW to provide Medi-Cal and use the evidence-based Pathways Community Hub Institute (PCHI) Model services.


